# Highlights

## Service Delivery

Our primary service, the common roof™ model in both Barrie and Orillia continue to support a cluster of community based organizations – large and small, charitable and non-profit, through a shared space framework and collaborative approach. Many of these were deemed as essential services and as such, were vital to the continued support of the communities in which we operate. The common roof™ remains an innovative and unique investment in social purpose real estate, one that requires continued support and the ongoing investment of time and resources to continue to thrive.

This past year, activities to support the common roof™ included continued collaboration with our Tenant organizations to ensure that their needs – as our primary client group – were being met. In addition, our Maintenance Services worked with local subtrades, contractors among others, to ensure the best and most cost-effective approach to supporting our building and maintenance needs.

Shared service areas such as reception and the internet were reviewed to ensure responsiveness to our tenant organizations and their client groups. This became even more important as a result of COVID-19 because it impacted our ability to support and work with tenants as they faced many unknowns including the push to work remotely and supporting clients virtually.

This past year also saw our partner agencies receive almost \$90,000 as part of the common roof™ unrestricted sustainability grant to ensure sustainability in partner agency service delivery capacity.

As we faced the uncertainty created from the new COVID reality, we worked alongside our Tenants to refine, revise and create policy and protocols that would be put into place later on in 2020 as Tenants began to contemplate return to work strategies.

During this period, we continued to move forward with the development of our Collingwood common roof™ and Rotary Hub. Work on the retrofitting of the Hub space continued over the latter part of 2019 and will continue through the middle part of 2020. When complete, this location will be the new home for 3 Tenant organizations as well as a permanent meeting space for the Rotary Club of Collingwood.

Our experience with the Collingwood build has created new partnerships and connections within the Collingwood and surrounding community that will help us as we continue to grow and develop our common roof™ model.

A highlight for two key Partners at the Barrie common roof™ was the start of leasehold improvements that would enhance their current working space and better support staff teams. Work began in late 2019 and was paused for a while during the start up of shutdowns and Provincial directives in early 2020. It is back on track with an anticipated completion of late 2020.



# Highlights

## Resource Development

Work continued this past year with our overall fundraising and granting activities in support of New Path Youth & Family Services. Our annual HelpTheIn5 Fund, along with our new monthly donors and third-party events helped to raise over \$18,000 for those services not covered by current government funding. A big thank you once again to those donors who step up year after year in aid of the great work New Path does day in day out.

Our Ventures program continued to raise funds for the work of the New Path Foundation through various maintenance and service contracts – both within the common roof™ facilities and in the community. Looking forward, we will continue to investigate ways of building on these revenue streams to offset our yearly operational costs and ensure our long-term financial sustainability and health.

During this year we launched the Glen Newby Scholarship Fund in recognition of Glen Newby, the outgoing C.E.O for New Path Youth & Family Services, and his tireless work and advocacy for children and youth mental health. Working in partnership with New Path Youth & Family Services, a working group was created to develop application criteria and processes leading to a call for applicants in late 2019. At the time of this report, I am pleased to announce that three young people are recipients of a total of \$5,000 in scholarship funding to help them realize their post-secondary goals. This fund will be available for applications each year moving forward and will honour Glen's legacy of investing in young people.





# Capacity Building

As our strategic plan wrapped up this year, time was spent reviewing progress to date and beginning the discussion of “what's next?”. One area of focus was on the capacity of the Foundation to continue to grow based on current resources and commitments. A key decision during this year was to investigate the hiring of a full time Manager, Finance and Operations to support day to day operational areas while allowing the C.E.O. to focus more on strategic items such as developing external connections and opportunities. It is hoped that this position will be in place by late 2020.



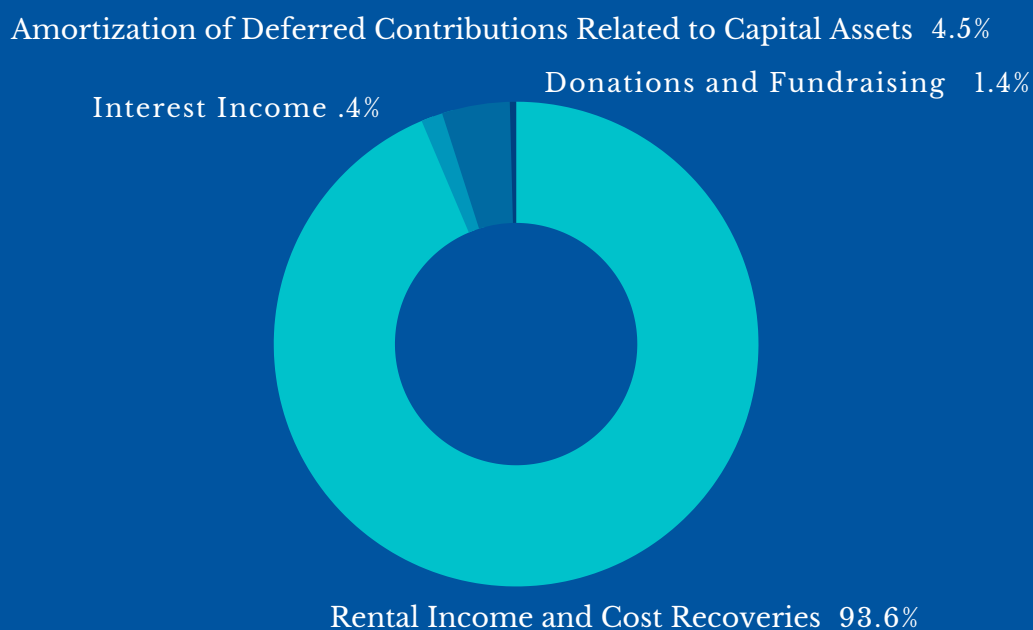

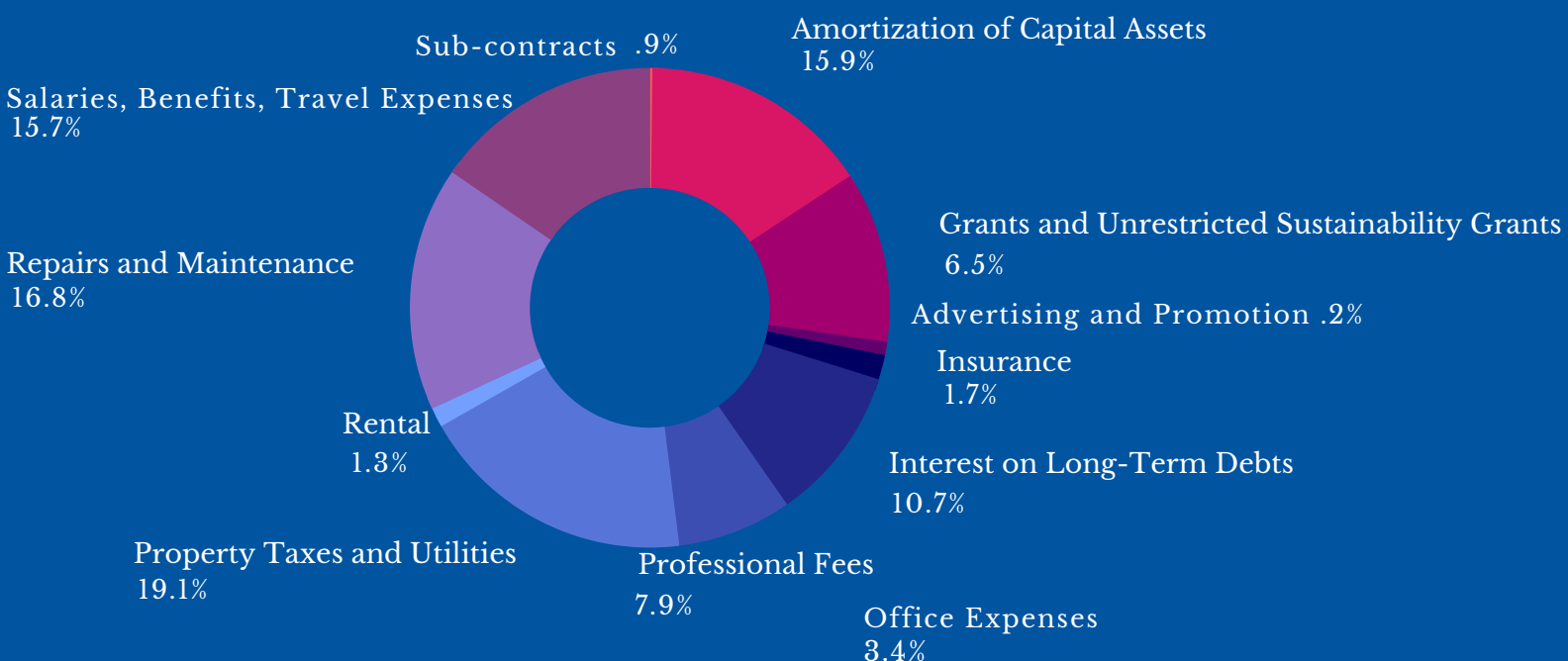

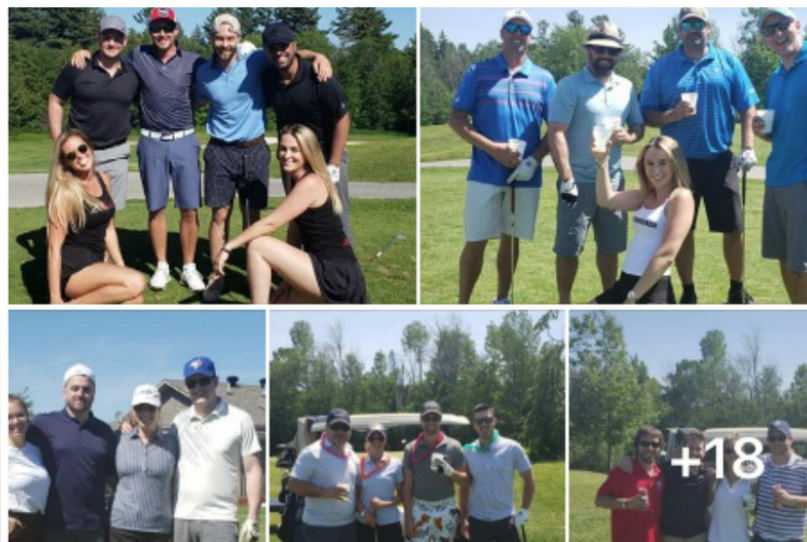
